



Terms and Conditions

The1DollarThing - hereinafter "Company" is a direct selling company marketing its products to the consumer through direct marketing. The policies herein apply to all Members/Reps of the Company.

1. I am of legal age in the state of my residency. I understand and agree that I am an independent contractor, responsible for determining my hours and business activities, in compliance with the terms and conditions of The1DollarThing.

2. I acknowledge and affirm that the agreement between The1DollarThing and its Member/Reps does not constitute an employer/employee relationship, agency, joint venture, or partnership between the Company and the Member/Rep.

3. As a Company Member/Rep, I will be an independent contractor responsible for my own business and not an employee of The1DollarThing. I will not be treated as an employee by any laws covering employees including but not limited to the Federal Insurance Contributions Act, the Social Security Act, and the Federal Unemployment Tax Act.

4. To maintain a viable marketing program and to comply with changes in federal, state, and local laws or economic conditions, Company may revise its Terms and Conditions from time to time.

5. I understand that I cannot use the name The1DollarThing or The1DollarThing trademarks or logo in advertising or my business name without prior approval from The1DollarThing.

6. Member/Reps may not quote the incomes of other Member/Reps to induce or persuade a prospect to become a Member/Rep.

7. No representation has been made by The1DollarThing or any employee or agent as to the future or post income, expenses, or profitability of becoming a Member/Rep.

8. Any Member/Distributor who engages in chat, email, posting, or any other medium content that is deemed damaging to the Company or its members, will be terminated. In the conduct of business, I will safeguard and promote the reputation of the products and services of The1DollarThing and shall refrain from any conduct that might be harmful to the reputation of the Company or the marketing of its products and services.

9. To enroll as a member/rep the cost is \$1.00 per month with a yearly \$10.00 administrative fee. The administrative fee covers all administrative setup costs for your retail tracking center, website, online back-office systems, hosting, and member/rep services support for one year.

I understand that I may cancel my membership without penalty or obligation within 3 days of joining the Company and 100% of the \$10 Administration Fee and the \$1 Membership Fee will be returned to me within 10 business days following the receipt of written notice to the company from me. To cancel this transaction, I will send a signed and dated letter stating my request to cancel by certified mail to: The1DollarThing, 2321 Shelburne Ave. SW; Decatur, AL 35603.

I further understand that after 3 days I can cancel my Membership at any time and that there will be no refund for monthly membership fees already paid but I will not have any future charges to any account. I also understand that all the benefits and products available to me as a Member/Rep will remain available to me in the calendar month that I cancel. I agree to not do any form of charge-back or stop payment on any payments that have already been made.

10. The1DollarThing has a ZERO TOLERANCE SPAM POLICY. We consider Spam to be unsolicited bulk email. I understand that failure to comply with this policy can result in my immediate termination. I further understand that if I am terminated due to Spam, I will no longer be eligible to receive any future compensation, will not be eligible for a refund, and will permanently lose access to my website.

11. The Company also reserves the right, at its sole discretion, to terminate any Member/Rep whom it considers to have business ethics that are questionable and may thereby damage the image of The1DollarThing.

12. I understand and affirm that there has been no guarantee of income, nor any assurance of profit or success represented to me. No warranties or guarantees either oral or written were made to me.

13. A Member/Rep becomes qualified to earn on all six levels of commissions with an active membership/product purchase and must produce a minimum of 3 new product sales within the last 12 months from the current day to earn commissions. To show company support, Member/ Rep is given a 90-day qualification grace period. Failure to pay the membership fee or annual administration fee in any month will disqualify the Member/Rep from receiving commissions for that month.

14. To purchase a Membership and thereby receive products and services from The1DollarThing, you do not have to be a Representative and earn commissions.

15. Commissions are run on the 30th of each month and commissions are paid out on or before the 15th of each month. Commissions are calculated in the following format:

16. When a member/rep earns \$1.00 or more in commissions, the software will deduct the \$1.00 from those commissions to pay for the next month's membership.

17. You must have a total of \$25 in earned commissions as a Basic Member to receive a commission payment.

18. You must have a total of \$25 in earned commissions as an Emerald Member to receive a commission payment.

19. You must have a total of \$70 in earned commissions as a Diamond Member to receive a commission payment.

20. There is a \$5.00 processing fee for each commission payment check/transfer.

21. For commissions to be paid to Members living outside the US an E-wallet account is required.

22. A Member/Rep's Membership may be transferred by will or assignment to immediate family members or heirs with approval from the Company upon receipt of proper documentation.

This Agreement and all ancillary agreements constitute the agreement between the parties. There are no other oral or written understandings or agreements between The 1 Dollar Thing and any Member/Rep.
